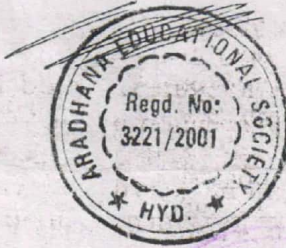

	<p>Bye-law:</p> <p>3 (iv). Disqualification of membership: A member shall cease to be member of the Society in the following cases.</p> <ol style="list-style-type: none"> a. On resignation or death. a. It adjudged insolvent or imprisoned for moral turpitude. b. On failure to pay dues to the society for one year. c. On failure to attend meetings for one year. d. Working against the interest of the society. <p>4 (ii) (e) Admission of new members and removal resignation of members.</p> <p>4 (ii) (f) To amend or repeal any existing bye-laws or to add new bye-laws.</p> <p>5 (iii) Functions of the Executive Committee:</p> <ol style="list-style-type: none"> a. Executive Committee shall exercise all power of the Society subject to conditions laid down by the General Body. b. Generally to carry on the business of the Society and to implement the decisions of General Body. c. To receive and spend any contributions, donations, subscriptions, gifts etc., and to make appeal for the same. d. To purchase, sell, transfer, mortgage or deal in property both moveable and immovable belonging to the Society including to take or give on lease. e. To take loans or to invest the funds of the society in the best manner. f. To sue or to institute legal proceedings on behalf of the society. g. To establish manage aid or assist educational institutions, libraries, reading rooms, hostels, health centres etc., and to make by-law s for their administration. h. To take management of any institution working for promotion of aims & objectives similar to that of the society. i. To appoint or remove staff of the society and to fix the fees for students and salaries to staff.



5(iii) (1) He presides over all meetings of the General Body and Executive Committee. He can cast his vote in the case of tie in decision making. He can supervise all branches of the society.

5(iii) (3) He is the Chief Executive Officer of the Society and custodian of all records relating to society and correspondent on behalf of the society. He has to take on record all minutes of the Society, would convene both Executive Committee and General Body of the society with the permission of the President. He guide the Treasurer in preparing the budget and Expenditure statement to place before the General Body for its approval.

5(iii) 5 He is responsible for all financial transactions and funds of the society. He has to maintain accounts properly along with vouchers. He has to prepare the accounts of the society jointly with the Secretary of President.

5(iii) 7 The Existing Bye-law 5 (iii) 7 relating to quorum shall be re-numbered as 5 (iv) -9 and new Bye-law 5 (iv) - 7 relating to notice, shall be inserted.

5 (iii) 7 Half of the total members for general Body meeting and ¼ for Executive Committee meeting.

j. To open bank account with any scheduled bank and to arrange operation of the same by any two members among President, Secretary and Treasurer of the Society.

5 (iv) Function of the executive Committee and office bearers.

5(iv) (1) President: After existing 5 (iii) (1), the following sub-para to be added.

In addition, he can cause, prepare and sign the minutes of General body and Executive Committee meetings. He can also sign the cheques with Secretary or Treasurer, whenever necessary.

5(iv) 3 Secretary: After existing clause 5 (iii) (3) the following sub papa shall be added.

In addition, the Secretary has to implement all resolutions of the Executive Committee and General Body Meetings. He has to manage day to day administration of the society and he has to negotiate enter into agreements, sings the documents etc with third parties on behalf of the Society. He can also sign cheques with President or Treasurer, as Required.

5(iv) 5 Treasurer: After existing clause 5 (iii) 5, the following sub papa shall added.

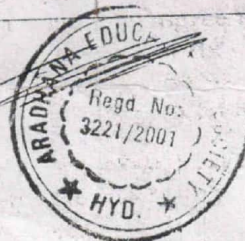
He has to sign the cheques alongwith President or Secretary of the society and he shall attend to functions assigned to his by the secretary.

5(iv) -7 New Bye-laws to be added.

Notice for general Body meeting shall be 10 days, In emergency, 5 days notice is to be given. Notice for Executive Committee meeting shall be one week and in emergency 3 days notice is required.

Notice shall specify the time, date, venue and agenda for the meeting.

5.(iv) 8- Quorum: the Existing bye-law is replaced with following. The quorum for General body Meeting is half of total members or 5 members present.

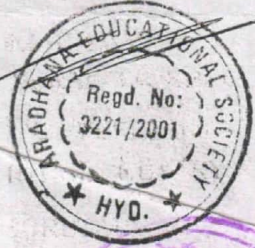
